DEALER REQUIRMENTS

All prospective BLOX Racing wholesale accounts are required to submit the following documents:

- Completed and signed dealer application form
- Completed dealer classification form
- Photocopy of business license
- Photocopy of seller's permit

- Signed resale certificate (mandatory for CA)

- MAP agreement form
- Credit card authorization form
- Credit application

TERMS AND CONDITIONS CONTINUED...

AVAILABLE WHOLESALE ACCOUNT TYPES*

BLOX Racing offers wholesale accounts a simple program that maintains affordability, while still providing strong profit margins. The following are the accounts types and a brief description regarding each.

Keep in mind that all necessary documentation must be received by your sales representative before an account can be created.

- **JOBBER ACCOUNT**
 - No required initial purchase order
 - Exceed \$3,000.00 in total sales within one calendar-month **OR** average \$3,500.00 over three calendar-months, you may be considered for our Dealer Account program

- **DEALER ACCOUNT**
 - \$3,000.00 required initial purchase order
 - Average monthly maintenance of \$1,500.00
 - Reviewed on a quarterly basis
 - If maintenance is not met after 2-quarters, account status will be changed to Jobber
 - Dealer Account must have a retail showroom or warehouse

- **WAREHOUSE DISTRIBUTOR ACCOUNT**
 - \$10,000.00 required initial purchase order
 - Average monthly maintenance of \$5,000.00
 - Reviewed on a quarterly basis
 - If maintenance is not met after 2-quarters, account status will be changed to Dealer
 - 30% of business must be wholesale

*No home-based businesses will be considered.

ORDERING

All orders must be accompanied by a Purchase Order Number (PO#) or a designated Reference Number (Ref#). Orders requiring special shipping instructions or shipping methods other than BLOX Racing standard shipping carrier, must be clearly stated on the purchase order.

To please orders, please use one of the following methods:

During business hours:

- Phone or fax purchase orders

After hours / weekends:

- Fax purchase orders
- Email purchase orders

Email & Instant Messenger:

TERMS AND CONDITIONS CONTINUED...

BACK ORDERS

In the event that any parts on the purchase order are out-of-stock, the entire purchase order will be held until the entire purchase order can be filled and shipped in its entirety, unless otherwise approved for partial shipments. Any back-orders will be filled when products are available. Back-orders will not be charged or billed until orders are completed.

SPECIAL-ORDERS

All special-orders will require a 50% deposit. The sale of all special-orders is final. If the special-order is canceled for any reason, the deposit becomes non-refundable.

PAYMENT METHODS

All initial purchase orders must be pre-paid using guaranteed funds until your wholesale account has been approved. However, if you choose to pay by company check the order will be held 7-14 days until the check has been verified for funds.

Once a wholesale account has been approved, the following payment methods become available:

PRE-PAY: Company or certified check, wire transfer, credit card
COD (standard fees apply): Company or certified check, cash
TERMS: On approved credit (Credit application must be completed)

PAYPAL: Please contact your sales representative for more details

INTERNATIONAL ORDERS: Must be prepaid by wire transfer

Accepted credit cards: VISA, MASTERCARD, DISCOVER, AMERICAN EXPRESS

RETURNED CHECK AND LATE PAYMENT POLICIES

BLOX Racing reserves the right to charge a \$25.00 service fee on all returned checks. All future orders thereafter MUST be pre-paid or COD with certified funds.

A 2% per month finance fee (A.P.R. of 24%) may also be assessed on all accounts 30-days past due.

BLOX Racing reserves the right to place a hold on any wholesale accounts that are consistently late on payments or past due.

SHIPPING METHODS

All wholesale accounts are responsible for all shipping charges incurred. All orders must be prepaid or COD prior to shipping, unless the dealer is on pre-approved terms. Purchase orders exceeding \$3,000.00 qualifies for free shipping within the continental United States.

The following carriers are used for all BLOX Racing shipments. The wholesale account may request another form of delivery, but must provide shipping details or instructions.

- Standard: FedEx Ground; USPS
- Freight: USF Reddaway
- International: Please contact your sales representative for a details and proper shipping quote

Other shipping methods available are:

- USPS (United States Postal Service): 1st Class, Priority, Express
- Federal Express: Priority Overnight, Standard Overnight
2-Day Express, 3-Day Express

WILL CALL & LOCAL DELIVERY

As a convenience for local wholesale accounts, BLOX Racing offers will call pickup and local delivery services. Please contact your sales representative for more details.

DROP-SHIPMENTS

- Each wholesale account will receive two (2) free drop-shipments each month. Thereafter, a \$5.00 service fee will be charged for each location drop-shipped to
- Drop-shipment service is only available for authorized wholesale accounts

DAMAGED/MISSING PRODUCTS

In order to provide proper customer service and follow-up, wholesale accounts must fill out and submit a RMA form.

- Damaged shipments must be reported within 48-hours after receipt
 - Please file a claim with the carrier
 - Submit a copy of the claim report to BLOX Racing
- Shortages must be reported within 5-business days after receipt
 - Please file a claim with BLOX Racing

For the proper RMA form, please contact your sales representative.

REFUSED SHIPMENTS

- Constitutes that any future business with BLOX Racing is no longer possible
- The wholesale account, or in certain cases the buyer, will be responsible for all shipping charges

CONDITIONS REGARDING WHOLESALE ACCOUNTS

- BLOX Racing reserves its rights regarding the acceptance, suspension or termination of all wholesale accounts.
- All wholesale accounts must have on file a completed dealer application, including any required documents listed in these terms and conditions and on the dealer checklist form. The checklist form is provided.
- All wholesale accounts must provide a personal guarantor. The personal guarantor will be responsible for all outstanding debts and costs associated with the wholesale account. The personal guarantor must be an owner or documented officer of the company.
- Net terms and credit limits will be approved upon successful verification of the credit application form. The credit application form is provided.
- BLOX Racing does not grant any exclusive territories or regions.

WHOLESALE ACCOUNT SUPPORT

BLOX Racing supports its wholesale account network with product advertising and promotions via industry magazines, consumer and trade shows, product and vehicle features, and other editorial features.

PRICING POLICY

BLOX Racing reserves its right to create, update, change or cancel any or all of its product pricing programs. Prices and structures may change without notice or consent from wholesale accounts.

MINIMUM ADVERTISED PRICE (MAP) POLICY

BLOX Racing has adopted and enforces a minimum advertised price (MAP) policy. The MAP Policy is designed to protect the integrity of BLOX Racing and its products, in addition to the integrity of its wholesale account program. BLOX Racing reserves the right to set, change or adjust MAP at its own discretion. MAP is published on all price sheets.

All advertised prices must be at or above MAP. The BLOX Racing MAP Policy is included in the wholesale account information packet.

PRODUCT DISCLAIMER

Some BLOX Racing products are legal for sale and use in CA only on vehicles which may never be used on public roads and highways. However, it is the buyer's responsibility to check and comply with all local, state or federal laws before installing and using BLOX Racing performance products.

The installation and use of BLOX Racing products may also affect or void a vehicle's manufacturer warranty and insurance coverage.

BLOX Racing assumes no responsibility for any damage or injury to persons or property resulting in improper installation, misuse or abuse of any product and will not be responsible for any claims of loss of profit, labor and delay, indirect, incidental or consequential damages that might be claimed as a result of failure of any part.

BLOX reserves its right, without notice, to make changes, updates or revisions to materials, specifications, product design, part numbers, packaging and labeling without incurring any obligation to the buyer for previously purchased merchandise.

LIMITED WARRANTY

No warranty whatsoever will be valid if the defect was caused by abuse, negligence, mishandling, and/or improper installation or tuning. BLOX Racing reserves its rights for determining and executing all warranty claims.

BLOX Racing warrants all products to be free of defects in materials and workmanship under normal use for a period of fifteen (15) months from the date of retail purchase. Any products being returned must be determined by BLOX Racing to be defective. All products found to be under warranty will be replaced or repaired by BLOX Racing.

RETURN POLICY

Any products being returned, for whatever reasons, must have a Return Merchandise Authorization (RMA) file opened. Returns will only be accepted from purchases made through an authorized wholesale account, including authorized online auction sites.

Contact your sales representative for the proper RMA form:

- Warranty claim (defective products)
- Product Return claim (must be in "like new" condition, stocking fee of 20% may apply)
- Damaged Goods claim (during shipping)
- Delivery Shortage claims (during shipping)

Special-orders cannot be returned for any reason.

All shipping to BLOX Racing is the responsibility of the claimant. Call-tags or shipping credit will not be issued and COD return-deliveries will not be accepted.

Please allow 7-10 days for inspection and response to the claim.

2008 POLICY REGARDING MINIMUM ADVERTISED PRICE (MAP)

Alinea, Inc. (DBA BLOX Racing) has unilaterally adopted a minimum advertised price (MAP) policy for all BLOX Racing performance products and accessories. This policy shall apply to all authorized wholesale accounts (Jobber, Dealer, WD), including catalog and internet retailers, who resell BLOX Racing performance products and accessories to end-users located in the United States and Canada.

Alinea, Inc. has adopted this policy in order to build and maintain integrity for BLOX Racing and its brand equity by emphasizing the value and quality of BLOX Racing performance products and accessories.

BLOX Racing MAP Guidelines

1. MAP for each product is listed on BLOX Racing price sheets. BLOX Racing reserves the right to make adjustments to MAP at its sole discretion, and at any time. All wholesale accounts will be notified and allowed ample time to make any necessary adjustments.
2. All advertised prices must be at or above MAP. Advertisements include, but are not limited to, the following:
 - a. Print ads (inserts, magazines, newspapers, catalogs, etc)
 - b. Broadcast (radio, television, faxes, emails, etc)
 - c. Direct mail (flyers, posters, coupons, etc)
 - d. Internet (company website, auction sites, search engines, banner ads, etc)
3. Advertising statements such as "call for prices" or "we'll beat anyone's prices" are acceptable and permitted.
4. Wholesale accounts are free to set their own actual resale prices for any products.

Internet Site Pricing

Pricing listed on internet sites are considered "advertised prices" and must adhere to MAP until the product is placed in the "virtual shopping cart" when applicable. Once the product is in the shopping cart or in check-out, MAP no longer applies.

This policy also applies to "fixed price" or "buy it now" auction sites. Auction-style listings do not apply to MAP.

Pricing Statements

MAP does allow for such statements as "call for price" or "we have the lowest prices" or "we'll match or beat any prices."

Price Matching Policies

Price matching policies are acceptable; however, they cannot be used as a valid reason to violate MAP. All advertised prices must be at or above MAP.

Bundling / Package Deal or other Special Offers

- You may only bundle BLOX Racing products together. The total price of products must be, at least, the sum total of each product's MAP.
- Offers for any free BLOX Racing product with the purchase of another BLOX Racing product(s) does not apply to MAP as long as the price of the free product is not advertised or listed.
- Free shipping or 0% sales tax do not apply to MAP



MINIMUM ADVERTISED PRICE (MAP) AGREEMENT

In order to help protect the integrity of our BLOX Racing wholesale account network, **MAP (minimum advertised price) will be enforced.**

Enforcement will be applicable to all forms of print and internet/online advertising, as well as, e-commerce sites and eBay retailers and similar auction type sites. Refer to Policy Regarding Minimum Advertised Price (MAP).

At the discretion of BLOX Racing, intentional and/or repeated violations of MAP can or will result in the termination of authorized status, including any pending orders, and the ability to participate in marketing programs, access and funding, including but not limited to:

1. Advertising or marketing reimbursements
2. Sales incentives, contests or promotions
3. Ability to receive special or bid pricing

Intentional and/or repeat violators of MAP will be subject to the following course of action:

- 1st Violation: A verbal warning will be issued to cease all advertisements which violate MAP.
- 2nd Violation: Authorized wholesale account will immediately be placed on hold for the period of two (2) business weeks.
- 3rd violation: Authorized wholesale account may be terminated.
 - 3rd violation will be subject to review on an individual basis. BLOX Racing reserves the right to determine alternative resolutions prior to wholesale account termination.

In an effort to help our wholesale account network maximize its profits, all wholesale accounts must be committed to MAP.

We appreciate your commitment and efforts to distribute BLOX Racing performance products and accessories. We will continue to assist each of you in achieving continued success.
